What I Do:

- I am an Energy Body Practitioner in the realm of Qigong healing. I work with the energetic matrix of the body. This includes your 5 element balance through jing, qi, and shen, as well as miasms and qi scarring held within the 5 elements. I address your 12 major organ meridians, 8 extraordinary meridians, acupoints, organs, and sense organs, nervous system, and endocrine system.
